BUSINESS TRAINING

Business Planning

Designed for participants who require a comprehensive business plan for funding purposes.

Key topics: business models, SWOT Analysis, Environmental Analysis, business strategy, market analysis, operations and logistics, financial projections.

Data Protection and GDPR: Level 1

Designed for staff and volunteers handing personal data in their work roles.

Key topics: Introduction to the GDPR, Key Data Protection Terminology, Strengthening the Rights of Individuals, The Principle of Accountability, Complying with the GDPR, Keeping Data Secure – Personal Top Tips.



Data Protection and GDPR: Level 2

Designed for supervisors, team leaders and departmental line managers.

Managing Regulatory Compliance

Key topics: Legal duties of company directors, company constitution, AGM, legal and administrative duties of company secretary, setting agendas, taking meeting minutes.

Introduction to Social Enterprise

Key topics: Social enterprise model canvas, generating ideas, researching needs, formulating business solutions, legal entities and governance implications, communicating the cause, developing rolling action plans.



Social Enterprise Development

Designed for early-stage social enterprises who wish to maximise their social impact.

Key topics: Articulating social outcomes and impact, building the team, developing business and marketing plans, projecting cash flow requirements, planning operations, developing the Board.



Business Development

Designed for established social enterprises who wish to grow their trading income.

Key topics: Framing problems and solutions, scaling social impact, financial management and break-even analysis, operations management, funding development, building respected brands.

GOVERNANCE AND OPERATIONS TRAINING

Operational Planning

Designed for business owners and departmental line managers.

Key topics: Business objectives, key performance indicators, tracking performance, allocating resources, break-even analysis, variance analysis, departmental and operational plans.



Developing Financial Policy and Procedures

Designed for small and growing businesses and non-profit organisations.

Key topics: Elements of financial management, handling income, expenditure, banking, fixed assets, travel expenses, petty cash, payroll, reserves, procurement and purchasing.



Charities Governance Code

Designed for trustees and managers of charities registered in Ireland.

Key topics: Purpose of the Charities Governance Code, charity classification, reporting requirements, the six principles explained, compliance record, evidencing compliance.



Writing Funding Applications

Committee Skills
